Ethanol at Argo closed at \$1.82 per gallon on Monday of last week, up 1 cent per gallon from the previous Friday's close. In an active session, LCFS credits in California closed at \$53.50 per MT, down \$2 per MT from the previous Friday's close. In an active day in RINS on Monday of last week, D4 RINS closed at 53 and ½ of a cent per RIN, up 1 cent per RIN from the previous Friday's close. Meanwhile, D6 RINS closed at 54 cents per RIN, up 1 and ½ cents per RIN from the previous Friday's close.

In a slower session on Tuesday of last week in RINS, D4 RINS closed at 53 and ½ of a cent per RIN, no change day over day. D6 RINS closed at 53 and ½ of a cent per RIN, down ½ of a cent per RIN day over day. Ethanol traded down on Tuesday of last week on the back of falling corn futures, closing at \$1.80 and ½ of a cent per gallon, down 1 and ½ cents per gallon day over day. LCFS credits in California, in a quiet session, closed at \$53 per MT on Tuesday of last week, down 50 cents per MT day over day.


LCFS credits closed out the day at \$53.50 per MT on Wednesday of last week, up 50 cents per MT day over day. In an active day in RINS on Wednesday of last week, D6 RINS closed at 55 and ½ of a cent per RIN, up 2 cents per RIN day over day. D4 RINS also closed at 55 and ½ of a cent per RIN, also up 2 cents per RIN day over day. Ethanol at Argo closed at \$1.80 per gallon, down ½ of a cent per gallon day over day.

On Thursday of last week, Ethanol at Argo closed at \$1.80 and ½ of a cent per gallon per gallon, up ½ of a cent per gallon day over day. LCFS credits in California, in a semi-active session, closed at \$54.50 per MT, up \$1 per MT day over day. In a slow day in RINS on Thursday of last week, D4 RINS closed at 55 cents per RIN, down ½ of a cent per RIN day over day. D6 RINS also closed at 55 cents per RIN, also down ½ of a cent per RIN day over day.

In a very busy end to the week on Friday of last week in RINS, D4 RINS closed out the day and the week at 55 cents per RIN, down no change day over day, but up 2 and ½ cents per RIN week over week. Meanwhile, D6 RINS also closed at 55 cents per RIN, no change day over day also up 2 and ½ cents per RIN week over week. Ethanol at Argo closed out the day, and the week, at \$1.82 per gallon, up 1 and ½ of a cent per gallon day over day, and up 1 cent per gallon week over week. LCFS credits in California in an active session closed out the day, and the week, at \$54.50 per MT, no change day over day, but down \$1 per MT week over week.






